## Refer-a-Friend Program Terms and Conditions

**The HotForex Refer-a-Friend Program offers the opportunity to claim a reward for simply introducing additional business to HotForex.**

1. Refer-a-Friend Program is offered by HF Markets (SV) Ltd (herein “the Company” of “HotForex”) to the Company’s clients.
2. Any Client referred to the Company under the Refer a Friend Program from a Referrer, must not be an existing Client of the Company or a direct family member of the Referrer.
3. The Referrer will be eligible to receive the Refer a Friend reward when the following conditions are met:
  - The deposit of the Referred Client has been credited into the referred Client’s trading account.
  - The Referred Client’s initial deposit is equal to or more than USD 300. Note: This reward is based on the Referred Client’s initial deposit of and cannot be applied to any subsequent deposits made by the Referred Client.
  - The Referred Client has completed at least 10 trades with a total volume size of at least 10 standard lots. For trading on Indices, U.S. Shares, Gold and Oil transactions, 1 lot traded counts as 0.1 lot towards completing the bonus volume requirements. For U.K. shares 1 lot traded counts as 1/1000 lot towards completing the bonus volume requirements. Only trades that have a 3 pip difference between open and close price are counted towards the Volume Requirements.
4. The Refer a Friend reward amount awarded is calculated based on the Reward Table, available in Company’s website.
5. The Refer a Friend program is not transferable.
6. In the event that the Referrer refers a client that has already been referred by an IB or Affiliate, the Refer a Friend bonus cannot be awarded.
7. The Referrer must not promote themselves as an agent, IB or Affiliate of HotForex.
8. HotForex reserves the right to impose a time limit, where by both the Referrer and the Referred Client must maintain a trading account for the minimum of one (1) month after the initial deposit has been made.

9. To claim the reward, the Referrer must send an email containing the Referrer and Referred Client's account numbers and the corresponding email addresses to [referrals@hotforex.com](mailto:referrals@hotforex.com) within 30 calendar days from the date that the Referred Client's trading account was opened. Requests that are received after this period will not be accepted.
10. Trading accounts participating in any other HotForex contest are not eligible to receive a Refer-a-Friend reward.
11. Refer-a-Friend accounts cannot participate in the HotForex Affiliate program. This means that HotForex Partners cannot receive commission from Refer-a-Friend accounts.
12. The Refer a Friend reward will be credited into the Referrers trading account when all the Terms and Conditions set out herein have been met in full. The reward amount may be used for trading purposes or, alternatively, may be withdrawn without restriction.
13. If the Company suspects that a Client has abused or attempted to abuse this or any other promotional program, the Company reserves the right to deny, withdraw and/or withhold the reward without the Client's consent. In the event that any stop losses are incurred as a result of such a removal the Company will not be held liable.
14. The Company reserves the right to unilaterally modify, change or terminate this Bonus Program or any of the terms and conditions included herein, at any time, without the Client's consent
